ASKOLL EVA: NEW AGREEMENT FOR THE SUPPLY OF ELECTRIC SCOOTERS FOR A SHARING SERVICE IN THE PROVINCE OF NAPLES

With this agreement, the number of Italian regions in which there are electric scooters for the sharing service rises to 7

Dueville (VI), 19th September 2023 - Askoll EVA S.p.A. - leading company in the sustainable mobility market that develops, produces, and markets e-bikes and e-scooters, as well as kits and components in the area of electric motors and batteries - announces that it has agreed with "Città di Leonia cooperative social" for the supply of 35 electric scooters which will be deployed in the municipalities of San Giorgio a Cremano (Na), Portici (Na) and Ercolano (Na), in sharing mode, where Askoll EVA arrives for the first time ever.

The models delivered are the Askoll eS2 sharing with an estimated value of over 100,000 euros.

The service is part of a sustainable mobility project, which benefits from the contribution of the Foundation with the South and addresses the issues of environmental protection, cultural promotion and the employment of disadvantaged people.

Thanks to this new order, Askoll EVA has ticked another Italian region where this type of service is already active, reaching 7 (Lazio, Lombardy, Piedmont, Liguria, Tuscany and Emilia-Romagna).

CEO Gian Franco Nanni said: "We are satisfied with this new agreement, which allows us to expand in southern Italy, further contributing to sustainable mobility and the growth of our electric scooters in Italy. It will be a pleasure to guarantee the residents of the municipalities of San Giorgio a Cremano, Portici and Ercolano the possibility of getting around their centres comfortably and conveniently, even on the well-known city ups and downs where Askoll EVA scooters guarantee maximum performance, in full respect of the environment ".
